

## INFORMATION CLAUSE PURSUANT TO THE INFORMATION OBLIGATION, ARTICLE 13 OF THE GDPR

1. Providing your real personal data and / or data about your business is voluntary however it is a obligatiry condition for the conclusion and implementation of the service / contract / order / cooperation and the continuation of already concluded contracts.

2. The administrator of your personal data is Droga po dom sp. z o.o. based in Łódź (hereinafter referred to as: Droga po dom) at ul. Łąkowa 7A building D lok. 213C, 90-562 Łódź KRS 0000986973 NIP 7272861530 REGON 522809559, e-mail address: biuro@drogapodom.pl (hereinafter: ADO).

3. PDA has appointed a Data Protection Officer, who you can contact by writing to the following e-mail address: iod@drogapodom.pl

4. Your personal data will be processed in order to provide the specified service

in the Regulations of the website www.drogapodom.pl. The legal basis for data processing is the provision of Art. 6 sec. 1 of the EU general regulation on the protection of personal data of 27 April 2016, no. GDPR Regulation

i.e. consent of the data subject and performance of the concluded contract.

5.The recipient of your personal data will be ADO employees, ADO contractors and external entities with whom ADO has concluded an agreement on entrusting the processing of personal data, such as accounting services, financial services (banks, payment services, financial institutions), forwarding and transport services (companies courier, post office), IT and legal services, marketing and analytics services.

6. Your personal data may be transferred to a third country, i.e. outside the EU and the European Economic Area, only in direct connection with the provision of the service and contracts concluded by ADO with external contractors.

7. Your personal data will be processed by PDC for the entire duration of the provision of services and after its completion for a period of 2 years, because this is the period of limitation of claims related to the concluded contract for the provision of electronic services.

8. Your data will be processed in an automated manner, including in the form of profiling.

9. You have the right to access your personal data, the right to request correction, deletion or limitation of processing of this data and the right to transfer data – on the terms set out in art. 15 – 21 of the GDPR Regulation.

10. You can withdraw your consent to the processing of data at any time (this involves the cessation of the service under the www.drogapodom.pl website in accordance with

with the provisions of the Regulations of the website www.drogapodom.pl).

In such a situation, the contract concluded with PDC is terminated. Withdrawal of consent does not affect the lawfulness of the processing which was carried out on the basis of consent before its withdrawal.

11. You have the right to lodge a complaint with the supervisory authority, which is the President of the Personal Data Protection Office, if you believe that the processing of your personal data violates the law.
