

REGULATIONS OF THE DROGAPODOM.PL NEWSLETTER

1. These regulations define the general conditions for the provision of the Newsletter service - electronic newsletter (sent in the form of an electronic letter - e-mail) and issued by the publisher specified in point 2 of these regulations.

2. The data of the Newsletter publisher are as follows:

hereinafter referred to as "**drogapodom.pl**"

3. **drogapodom.pl** informs that the Newsletter may contain commercial information within the meaning of the Act of 18 July 2002 on the provision of electronic services.

4. The newsletter is completely free of charge and available to all persons, provided that the persons wish to receive it on the terms set out in these Regulations.

5. The newsletter contains information on the offer of **drogapodom.pl** products and services, including: information on the offer and credit procedures of banks and financial institutions, the real estate market, credit advisers, central credit intermediaries, legal and banking documents, BIK, **drogapodom.pl** partner outlets, news from the call center drogapodom.pl, services contained on the website www.drogapodom.pl, current promotions and other news about **drogapodom.pl** and its products or services, including opinions, press and other materials, as well as links to company websites and channels in the social media of **drogapodom.pl** or to websites of friends and cooperation with **drogapodom.pl**.

6. The newsletter will be sent to the Users from the address of the Newsletter publisher, ie news@drogapodom.pl.

7. Each Newsletter contains:

a) information about **drogapodom.pl** which is the publisher of the Newsletter, including its contact details and contact details;

b) a completed field with information from **drogapodom.pl**, referred to in point 4 of these Regulations, and constituting the content of the Newsletter,

c) information on how to unsubscribe from the Newsletter service or change the e-mail address (e-mail address) of the User to which the Newsletter is sent,

d) reference to these Regulations.

8. In order to receive the Newsletter, the User should:

a) order the Newsletter service by providing your e-mail address (e-mail) in the electronic form available on the website www.drogapodom.pl or in the mobile application,

b) accept these Regulations by selecting the appropriate box in the electronic form and confirm the intention to receive the Newsletter by clicking / selecting the appropriate "Subscribe" button.

c) have an active e-mail address.

9. At the moment referred to in point 8 lit. b) above, an agreement is concluded between the Parties for the provision of Newsletter services, on the terms set out in these Regulations.

10. The User may at any time, without giving a reason and incurring any costs, may unsubscribe from the Newsletter service. For this purpose, the service user may click on the appropriate link in the footer of each Newsletter and send a request to remove from the list of subscribers or by entering his e-mail address (e-mail address) in the appropriate field, and then selecting the "Unsubscribe" or write directly to the e-mail address biuro@drogapodom.pl.

11. The User may re-order the Newsletter service at any time. For this purpose, the User should activate the service again by following the steps described in point 8 of these Regulations.

12. **drogapodom.pl** reserves the right to:

a) temporarily disabling the "Newsletter" service, if it is necessary for technical reasons,

b) complete cessation of the "Newsletter" service after prior notification of its Users, without giving any reason.

13. **drogapodom.pl** declares that the e-mail address provided by the user will not be made available to third parties.

14. **drogapodom.pl** declares that the e-mail address provided by the user will be processed in accordance with applicable regulations, in particular in accordance with the Act of July 8, 2002 on the provision of electronic services (consolidated text: Journal of Laws of 2002, No. of 2020, item 344 as amended) and in accordance with the Act of May 10, 2018 on the protection of personal data (Journal of Laws of 2019, item 1781) and the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27/04/2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC (general regulation on data protection) (Journal of Laws UE L 119, p. 1).

15. The processing of personal data takes place on the terms specified in the REGULATIONS and the PRIVACY POLICY of **drogapodom.pl** (available at www.drogapodom.pl).
